1. The application can be entertained as per-Schedule given as under :-

(I) Within two years Rs. 1070/00/-

(ii) Within five years Rs. 2070.00/-

(iii) Within ten years Rs. 3070.00/-

(iv) After ten years Rs. 4070.00/-

The Board is satisfied after enquiry and inspection of School records pertaining to the
first admission of a particulars candidate in a recognised School that the mistake was
due to clerical error in transferring the date of birth from on record, register or document another record, register or document.
