

1. Tenders must be submitted **online through EPADS (Punjab.eprocure.gov.pk)** on or before **27-6-26 (date) at 11:00AM (time)**. The Bid Security of the online tender must be submitted to this office in time through courier service/by hand. Only **online tenders submitted via EPADS** shall be accepted. **Late submissions shall not be entertained.** It is preferable that a **hard copy** of the tender also reaches this office within the stipulated time.
2. Each bidder shall provide **Bid Security equivalent to 5% of the estimated cost** in the form of **CDR/Bank Guarantee** (issued by a scheduled bank) within the prescribed time. Failure to submit the Bid Security/late receiving of CDR shall result in **disqualification of the bidder**. Cheque shall not be accepted under any circumstances.
3. The tenders shall be **opened on the same day at 11:30AM (time)** in the presence of bidders or their **authorized representatives**, whoever is present.
4. **Conditional and incomplete tenders** shall not be considered.
5. The procurement shall be conducted under the **Single Stage – Two Envelope Procedure through EPADS**.
6. The competent authority reserves the right to **reject any or all tenders** in accordance with **PPRA Rules 2014**, with reasons recorded.
7. The tender documents are available on the Board's website [www.biserawalpindi.edu.pk](http://www.biserawalpindi.edu.pk) and the PPRA website [www.ppra.punjab.gov.pk](http://www.ppra.punjab.gov.pk) for **viewing/downloading**. All tender conditions must be carefully observed.
